



The U.S. Deputy Assistant Secretary for European and Eurasian Affairs Paid Official Visit to Georgia

12.10.2018 TBILISI

- In the framework of his visit the Deputy Assistant Secretary George Kent held meetings with Speaker of the Parliament Irakli Kobakhidze, Vice Prime-Minister, Minister of Internal Affairs Giorgi Gakharia, Foreign Minister David Zalkaliani and other government officials.
- **Discussed:** Current security situation in the country as well as in the region, situation in occupied territories, the special role of the US in the conflict resolution process and key trends of co-operation within the margins of strategic partnership between the two countries.
- During the visit, George Kent has visited the villages along the occupation line and met with the representatives of the EU Monitoring Mission.

Statement by the MFA of Georgia on the 45th Round of the Geneva International Discussions

9-10.10.2018 GENEVA

- During 45th round of the Geneva International Discussions, the importance of ensuring the effective functioning of Incident Prevention and Response Mechanisms, as well as the necessity of execution of justice with regard to the cases of murder of Archil Tatumashvili, Giga Otkhozoria and David Basharuli were raised.
- The representatives of the US, EU Monitoring Mission and Georgia pointed out that the Russian Federation blatantly violates the EU mediated 12 August 2008 Ceasefire Agreement and called upon Moscow to fully implement its international obligations, inter alia to withdraw its occupying forces from the territory of Georgia.
- The next round of the Geneva International Discussions will be held on 11-12 December 2018. [MORE](#)

The Member-States of the Organisation de la Francophonie Have Expressed their Support for the Territorial Integrity of Georgia

- The leaders of 84 members of Organisation de la Francophonie (OIF) supported a Resolution on Crisis Resolution and Peace Consolidation. The resolution once again reaffirmed support to Georgia's territorial integrity and sovereignty as well as importance of the peaceful resolution of conflict based on the principles of international law and of the complete and unconditional fulfillment of the 12 August 2008 Ceasefire Agreement.
- The OIF members have also expressed their support for the Geneva international discussions that are aimed at addressing the consequences of the 2008 Russia - Georgia war. The Georgian delegation was represented at the summit by the Minister of Justice Thea Tsulukiani. [MORE](#)
